AustCham over the years has developed a proud tradition of providing benefit for its community. This year has been no exception as we continue to put both time and money into worthwhile projects aimed at delivering tangible benefits to those less fortunate. This mindset forms the bedrock of AustCham's Corporate Social Responsibility (CSR) and is something that can be seen in the past month's events.

On Saturday 3 October AustCham celebrated the 2015 AFL Grand Final at the new 3 Alley Pub in Itaewon. The much anticipated clash between the Hawthorn Hawks and the West Coast Eagles turned out to be a very one sided event,

with the Hawks winning by 46 points. Irrespective of the match, whatever your allegiance, the most pleasing aspect for AustCham was the raising of over KRW 700,000. This money was raised through a very successful raffle which contained some fantastic prizes including cases of beer provided by SAB Miller, meat packs provided by MLA, as well as several vouchers from 3 Alley. Furthermore, the Commonwealth Chambers' Networking night on 8 October saw AustCham work with the British, Canadian, Indian and Kiwi Chambers to raise a further sum of over KRW 2.5 Million for the Jeon Jin Sang clinic and hospice.

The money raised from these raffles will assist AustCham in reaching its 2015 CSR goal of donating KRW 10 million to charitable organisations.
